

**POCAHONTAS COUNTY COUNTRY CLUB  
MEMBERSHIP POLICIES AND PRIVILEGES**

**I. POLICY**

- A. Each member shall adhere to all rules, regulations, policies, and procedure set forth by the board of directors of Pocahontas County Country Club and its representatives.
- B. Pocahontas County Country Club or its representatives will not be responsible for any accidents, damages to personal property, and/or lost or stolen property.
- C. Pocahontas County Country Club reserves the right to refuse and or reject any application for membership including those who have an unpaid balance from previous years.
- D. Membership privileges may commence upon payment of at least 50% of membership dues and 100% of cart lease fee, if applicable, unless another payment schedule has been arranged with the manager . All balances due must be paid in full by August 1.

**II. DEFINITIONS**

- A. GOLF SEASON: The normal season when the course is mowed and maintained and clubhouse services are available is from April 1 through October 31 of each year.
- B. UNLIMITED GOLF: This entitles the member the privilege of playing any amount of golf on any day during the golf season with the exception of special event days.
- C. INDIVIDUAL MEMBERSHIP: This membership entitles the individual unlimited golf membership status.
- D. FAMILY MEMBERSHIP: This membership entitles spouses and dependent children through age 18 and any dependent children through age 22 that are enrolled in college full-time (12 hours) unlimited golf status.
- E. STUDENT MEMBERSHIP: This membership entitles any student that is enrolled in grades 4 through 12 at the beginning of the golf season or any college student enrolled full time (12 hours) unlimited golf membership status.
- F. WEEKDAY GOLF MEMBERSHIP: This membership entitles the member the privilege of playing any amount of golf on Monday, Tuesday, Wednesday or Thursday with the exception of special event days.
- G. WEEKEND GOLF MEMBERSHIP: This membership entitles the member the privilege of playing any amount of golf on Friday, Saturday, or Sunday and holiday Mondays with the exception of special events days.
- H. PARTIAL MEMBERSHIPS: There are **no** partial or pro-rated memberships available. However, special ten rounds of play with cart or twenty rounds walking memberships are available.
- I. CART TRAIL FEE: This fee entitles member to use and park a privately owned member's cart at the golf course for use by that membership during the golf season. It is understood that the owner is responsible for the maintenance, use and safe operation of that cart by that membership or other additional users of the cart. PCCC and its representatives will not be held liable for the security, use, maintenance, operation and/or damage or injuries that may be caused by or to the cart or its users. Members are encouraged not to lend out their cart to others.
- J. ADDITIONAL USER FEE: This fee entitles a member to use another's member-owned cart on a recurrent or regular basis without paying the normal cart fee that may be applicable.
- K. CART USE: All cart use requires the user to have a driver's license unless a parental wavier form has been signed.
- L. SPECIAL EVENTS: Special events are any scheduled event that requires the course to be closed. This may include such events as: high school, fundraiser or corporate tournaments. Advanced notice will be posted.
- M. MEMBERSHIP CARDS: Membership cards will be issued when the membership is paid in full.
- N. HANDICAP: Members must pay an additional fee to have a handicap card through the WV Golf Association.
